The only warranty offered by NZ Consumables Ltd is the manufacturers warranty accompanying the goods and in no event shall the liability for direct or consequential damages exceed the price paid for the goods.

Prices & Returns Policy

You can order from NZ Consumables Ltd with complete confidence. If for any reason you are not completely satisfied, just return the goods within 14 days of purchase. Note the goods must be unopened with the original packaging in pristine condition. We will refund your original purchase price, or we will replace your order. The purchaser is responsible for the cost of the products to be returned to us. Please include a copy of your invoice.

Although every effort has been made to ensure all details and pricing is correct we do not take any responsibility for errors or omissions. All prices will be as at the date of delivery. Due to the rapidly changing market the availability, price, and specifications, may change from time to time, we therefore accept no liability should any of the goods become unavailable, prices or specifications change from those presented on this website. However we will endeavour to advise of change before dispatch of goods.

ALL PRICES ARE EXCLUSIVE OF GST.

Payment

Terms of payment are net 20 days after end of month. These terms shall apply to all present and future transactions and are not negotiable unless agreed in writing by the Company. Upon insolvency or receivership, title to the goods shall pass only upon full payment of all outstanding monies to the Company. The acceptance by the Company of any cheque or negotiable instrument shall not constitute payment until the same has been honored.

In addition to any right of lien to which the company may be by law entitled, the company shall (in event of the Customers insolvency of going into receivership) be entitled to a general lien on all goods of the customer in the company's possession (although such goods or some of them may have been paid for) for the unpaid price of any goods sold and delivered to the customer by the Company under the same or any other contract.

Without prejudice to any other rights of action the company may have, unless payment is made to the company on the due date for payment, the customers account will be automatically suspended until it is brought within the trading terms offered by the Company.

Ownership of goods sold by NZ Consumables does not pass to the purchaser, until payment is received in full.

Privacy Act / Collection of Overdue Money

As NZ Consumables may use a credit agency to check your credit details you agree and acknowledge that all personal information supplied by you may be used or held for the purpose of obtaining credit reports, character references or credit statements to assess your credit worthiness.

You agree that you will upon demand pay all of NZ Consumables expenses and legal costs in the collection of all overdue monies. NZ Consumables Ltd reserves the right to charge 2% interest per month on any overdue monies.

Delivery

Free delivery New Zealand wide. For urgent service or bulk items (ie. Commercial printers), additional freight charges may apply.

All deliveries are shipped either via NZ Couriers or Courier Post generally overnight for outside Wellington.

All claims for shortage or damage during delivery must be made to NZ Consumables Ltd within 7 (seven) days of the date of delivery. Where products appear to be damaged or missing, contact us immediately.

We will make every effort to ensure delivery of products is on time, but will not be liable to you for any loss or damage arising in any way from delay in delivery.
